Biographies of the Independent Members of the Technical Committee

Mr. Ignacio Trigueros Legarreta is an Independent Member of our Technical Committee. He has an extensive and illustrious background in academic and teaching experience. He is *the head of the Economic Research and Analysis Center of the Instituto Tecnológico Autónomo de México* (ITAM) and a full-time professor at the same institution. He has served as advisor in various government agencies and has been credited with several recognitions. He has a degree in Economics by the Instituto Tecnológico Autónomo de México and both a Master and a Professional Doctoral Degree in Economics by the University of Chicago.

Mr. Antonio Hugo Franck Cabrera is an Independent Member of the Technical Committee and Chairman of the Corporate Practices Committee. With more than 45 years of experience in corporate law, finance, and securities, he has advised several companies, both in Mexico and abroad, in mergers and acquisitions and strategic alliances. He has actively participated in the incorporation of several banks and financial groups in Mexico and was a legal advisor to the group of banks that assisted the Mexican Government in the reorganization of public debt from 1982 thru 1992.
